



Due to demand for tee times and outing reservations, the enclosed Outing Contract must be executed to reserve Mainland Golf Course for your event. Please read the all the materials before returning the contract with your deposit (**\$250 for tee times / \$500 weekday shotguns / \$1,000 for weekend shotguns**)

Depending on the number of players and the time/day of the week, you may reserve the golf course on a tee time basis, modified shotgun or full shotgun start. The requirements for each are listed on the next page.

Tee Time Outings (20 or more players, any day or time of week)

The final head count due 5 days prior to the event becomes the guaranteed minimum for billing purposes. If your count drops from this total before the outing, you are still responsible for the guaranteed amount.

All scramble formats must be approved in advance, no weekend tee time scrambles are permitted!

Shotgun Outings (28 or more players, minimum varies with day/time of week, see next page)

The final head count due 7 days prior to the event becomes the guaranteed minimum for billing purposes. If your count drops from this total before the outing, you are still responsible for the guaranteed amount.

Please contact Mainland Grille at 215-256-6192 ext. 233 to discuss your F & B requirements.

Reserving times for your group means denying access to those times for anyone else. It is our recommendation that you collect fees in advance of your outing to cover last minute cancellations and no shows.

The Golf Outing and any F & B invoices must be settled on the day of play.

You will be given these invoice totals when contacted prior to the event when confirming head counts.

The return of this signed contract, along with your outing deposit check (**payable to Mainland Golf Course**) will confirm your event date and time. This deposit is fully refundable, if cancellation notice is given at least twenty eight (28) days for shotguns, (14) days for tee times before the date of your event.

Cancellation notice less than indicated above will result in forfeiture of the entire deposit amount.

All shotgun starts are offered the following

- Complete cart set up and staging area

- Placement of rules/info sheets and giveaway items on each cart
- All skill hole signage (closest to pin etc.) set up and retrieval
- Placement and retrieval of all hole sponsor signage
- Pre-round bag handling, (\$1 per bag gratuity appreciated, not invoiced)

The group contact must provide a typed list of pairings at least (3) day's prior to the event
All outing materials must be delivered (2) hours prior to the start to insure placement by staff

28-59 players (2 free passes) 60-80 players (3 free passes) 81 + players (4 free passes)

Please note

Shotgun starts do not guarantee course exclusivity

The golf course staff **will** assign starting hole assignments for all shotgun outings
All outing formats must be approved by staff, all play is from white tees or forward

1. All tee time starts require a **\$250.00** deposit; along with the signed original contract.
2. This deposit amount will be deducted from balance of total golf fee. ***Less than (14) days notice of cancellation will result in forfeiture of the entire deposit amount.***
3. **(14)** days prior to the event, and updated head count is due.
4. A ***final guaranteed*** head count is due **(5)** day's prior to the event.
5. ***This number will be used as a guaranteed minimum for billing purposes. The final bill must be settled the day of play, or free guest passes (if qualified) will not be issued.***
6. **All alcoholic beverages** must be purchased on site, no exceptions.
7. A copy of the Mainland Golf Course Rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.
8. All participants are required to abide by the posted rules and regulations of Mainland Golf Course. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.
9. The **person or entity** reserving the golf course pursuant to this contract **shall be responsible for any and all damage to golf carts, property and/or persons caused by outing participants.**
10. In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course staff, the outing may be rescheduled, or a billing adjustment will be offered.

SHOTGUN OUTING CONTRACT

1. All shotgun starts require a **\$500** deposit, **\$1,000** for weekends; along with the signed original contract.
2. This deposit amount will be deducted from balance of total golf fee. ***Less than (28) days notice of cancellation will result in forfeiture of the deposit amount.***
3. ***(14)*** days prior to the event, and updated head count is due. ***If the number of players has fallen below the minimum required for a shotgun start, the outing will be converted to a tee time start. A shotgun start can still be arranged, by agreeing to pay the minimum needed.***
4. A ***final*** head count is due ***(7)*** day's prior to the event. ***This number will be used as a guaranteed minimum for billing purposes.*** If your count drops the day of play, you are still responsible for guarantee.
5. ***The Outing Invoice must be settled on the day of play, or free guest passes will not be issued.***
6. All Wed-Fri and Weekend shotguns require purchase of Food & Beverage from the facility. The Food & Beverage bill will be on a separate invoice. **All alcohol** must be purchased on site.
7. A copy of the Mainland Golf Course Rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.
8. All participants are required to abide by the posted rules and regulations of Mainland Golf Course. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.
9. The **person or entity** reserving the golf course pursuant to this contract **shall be responsible for any and all damage to golf carts, property and/or or persons caused by outing participants.**
10. In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course staff, the outing may be rescheduled, or a billing adjustment will be offered.

COURSE RULES & REGULATIONS

All players must register with the Golf Shop before starting and obtain a valid receipt

**Proper attire required: Soft spikes only, appropriate golf shirts
Tee shirts, tank tops, sweatpants and cut offs are not permitted**

All alcoholic beverages must be purchased on site. Personal coolers are not permitted.

Golf cart operators must possess a valid driver's license, maximum two riders per cart

Golf cart fee is for a "shared" cart, no more than two carts per foursome

Golf cart riders must stay on cart paths near tees and greens, and adhere to stated cart restrictions

Each player must have his or her own set of golf clubs

Fivesomes are not permitted; singles and twosomes must pair up when asked by Golf Course Staff

Rain Checks are issued only if course closed due to weather

Mainland Golf Course is not equipped with a weather radar system; play is at your own risk

Please respect the private property surrounding the golf course

Our goal for maximum pace of play is four (4) hours and twenty five (25) minutes

Be aware of pace of play clocks on the course to monitor your progress

Stop Slow Play: keep pace with the group in front of you, play "ready" golf, no more than double par

Observe proper golf etiquette: repair ball marks, replace divots and rake footprints in bunkers

USGA Rules of Golf govern all play, except where modified by local rules
