

Due to demand for tee times and outing reservations, the enclosed Outing Contract must be executed to reserve Mainland Golf Course for your event. Please read all the materials before returning the contract with your deposit. Non-Refundable Deposits: \$250 for tee times / \$500 for weekday shotguns / \$1,000 for weekend shotguns

Depending on the number of players, the desired time and the desired day of the week, you may reserve the golf course on a tee time basis, modified shotgun or full shotgun start. The requirements for each are listed on the next page.

All scramble formats must be approved in advanced. There will be no weekend tee time scrambles permitted.

Reserving times for your group means denying access to those times for anyone else. It is our recommendation that you collect your outing fees in advance to cover any last-minute cancellations and/or no shows.

The return of the attached signed contract, along with your deposit, will confirm your events date and time. This deposit is **non-refundable**.

The Golf Outing and any Food & Beverage invoices must be settled on the day of play.

Golf Outings and Food & Beverage are invoiced separately. If paying with check, two checks will be required, one for Mainland Golf Course for the golf and one for Mainland Grille for any Food & Beverage.

Shotgun starts do not guarantee course exclusivity. The golf course staff will assign starting tee assignments for all shotgun outings. All outing formats must be approved by the golf course; all play should be from the white tees or forward. If the number of players drops below the minimum for a full shotgun, the course has the right to change the event to a modified shotgun or tee time start.

## **Rules and Regulations**

- 1. All players must register with the Pro Shop before starting and obtain a valid receipt.
- 2. Proper attire is required at all times. No metal spikes, tee shirts, tank tops, offensive graphics, sweatpants and cutoffs will be permitted.
- 3. All alcoholic beverages must be purchased on site. Personal coolers are not permitted and will be confiscated.
- 4. Golf Cart operators must possess a valid driver's license.
- 5. Maximum of 2 golfers or riders per cart and maximum of 2 golf bags per cart.
- 6. Golf cart fee is for a "shared" cart, no more than two carts per foursome.
- 7. Golf cart riders must stay on cart paths near tees and greens. Stated golf restrictions must be followed.
- 8. Golf carts should never be driven down public roads.
- 9. Look both ways before crossing public roads and abide by designated stop signs posted by the course.
- 10. Each player must have his/her own set of golf clubs.
- 11. No Golf Shots should be taken off the greens. If your ball lands on another golf hole's green, pick up your ball and drop it off the green/collar/fringe into the closest fairway/rough.
- 12. Rain checks are only issued if the course is closed due to weather.
- 13. The golf course is not equipped with a weather monitoring or alert system, players are assuming all responsibility and playing at their own risk.
- 14. Do not enter private property. Remain on golf course property.
- 15. Be aware of pace of play clocks on the course to monitor your progress.
- 16. Stop Slow Play: Keep pace with the group in front of you, play "ready" golf and no more than double par.
- 17. Use Proper Golf Etiquette: Repair ball marks, replace divots, rake bunkers and place all trash in trash cans.
- 18. USGA Rules of Golf govern all play except where modified by local rules.
- 19. There is zero tolerance for any type of harm to employees, physical or verbal.
- 20. Patrons are responsible for their own alcohol consumption. Please drink responsibly. Bella Vista Golf Course, Mainland Golf Course and Morgan Hill Golf Course have the right to refuse service to any person(s) that appears to be intoxicated. Any person(s) consuming alcohol must be 21 or older.
- 21. All kegs are to remain at designated locations. Kegs are not to be moved by any patrons and must remain on golf course property.

## **Mainland Golf Course Local Rules and Regulations**

- A. Golf carts are not permitted on the golf range.
- B. Golf Range is limited to 200 yards. No Drivers are permitted on the range.
- C. Range balls must be purchased in the Pro Shop. No shag bags are permitted on the range.
- D. Drop areas are designated on #5 and #9. Please use them if your ball ends up in a hazard or Out of Bounds.
- E. If you see a person(s) vandalizing the course, please call the Pro Shop immediately with their cart number and/or a brief description.

- 1. All shotgun starts require a \$500 deposit for weekdays, \$1,000 for weekends; along with the signed original contract.
- 2. The non-refundable deposit amount will be deducted from the balance of total golf fees.
- 3. A preliminary count of participants is due fourteen (14) days prior to the event. If the number of players has dropped below the minimum requirement for a shotgun start, the outing will be converted to a tee time start. A shotgun start can still be arranged by agreeing to pay for the minimum number of players required.
- 4. A final head count is due seven (7) days prior to the event. This number will be used as a guaranteed minimum for billing purposes. If your count drops the day of play, you are still responsible for the guaranteed minimum.
- 5. The course has the right to change the event from a full shotgun to a modified shotgun or tee time start if the number of players drops below the minimum required.
- 6. The Outing Invoice must be settled on the day of play, or free guest passes will not be issued.
- 7. All Wednesday to Friday pm shotguns and Weekend shotguns requires purchase of Food & Beverage from the facility. The Food & Beverage bill will be on a separate invoice. All alcohol must be purchased on site.
- 8. A copy of the Mainland Golf Course Rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.
- 9. All participants are required to abide by the posted rules and regulations of Mainland Golf Course. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.

Mainland Golf Course is taking measure and precautions to assist you to voluntarily proceed with your Outing or Event and is implementing the following precautions for all events:
